E911 Director Zim Schwartz distributed TYD totals for 2018 to the Commission. (Exhibit 1) Schwartz highlighted the report and informed commission that they will soon be filling six new slots for E911 operators. Schwartz informed Commission that her and staff member are currently following Senate Bill 291 and House Bill 883 and E911 supports these bills.

Clay Goddard Health Department Director introduced to the Commission Stephanie Wall. Ms. Walls gave brief highlights of the flu season. The flu vaccine is approximately 47% effective this year 2018 season was 38% effective. Zero pediatric deaths have been reported in Greene County. Goddard explained to the Commission of an upcoming Medical Marijuana State Seminar at OTC on March 7, Lincoln hall Rm 211. Assistant Director Katie Towns and Goddard gave an update on Community Mental Health Needs Assessment. The health department will be releasing a report to the community the 2<sup>nd</sup> week of April and will adopt a plan at that time.

Sons of the American Revolution member Howard Fisk greeted the Commission. Fisk explained that Commission in years past have allowed the organization to give brief celebrations in the historic courthouse, Fisk would like the Commission to continue on with this tradition. Flag Day in June and Nathanael Greene Day in August are the days they celebrate and Fisk would like to incorporate the Commission into the celebration. Commission gave the go ahead to continue on with the celebrations as it is an important event to celebrate with employees and citizens alike.

OEM director Larry Woods updated the Commission on the mini grant they applied for. Woods explained that unfortunately they did not receive the grant, upon contacting to get information as to why it was explained that the money in the mini grant was awarded to counties asking for storm siren maintenance. Woods will be out of the office Monday until Friday of next week for training in Atlanta. Next week is severe weather awareness week and OEM will highlight severe weather event every day of the week. 3-5 inches of snow is anticipated for the weekend. Woods highlighted February numbers.
