Once you have requested access complete Form 4379 and submit it to the Department. We will validate the information provided on the form and grant access as requested.

The reports you will receive contain confidential information. All persons listed on the form and any attachments are subject to the provisions of Section 32.057, RSMo. Those listed can only access the information in performing their official duties related to the administration of the tax and cannot disclose this information to the public or any other official who is not authorized to receive it.

Discussion and Possible Vote: Effective Date of COLA

The Greene County Commission has made certain decisions regarding the 2021 Budget. Among those decisions is that a 1% COLA shall be placed in effect for all 26 pay periods paid in the 2021 Budget year. To this end, Commission is ordering that the effective date of the 1% COLA is the pay period beginning December 27, 2020.

Discussion and Possible Vote: Effective Date of 2021 Step

The Greene County Commission has made certain decisions regarding the 2021 Budget. Among those decisions is ordering a one-step increase for eligible employees at mid-year. Traditionally, the mid-year step occurs with the second payroll deposit date in July. The Budget Office has provided for the last 13 pay periods of the 26 pay periods paid in the 2021 Budget year to be at these higher rates. These 13 pay periods begin June 27, 2021. This increase will first be reflected in employee paychecks deposited on July 16, 2021. To this end, Commission is ordering that the effective date of the one-step increase is June 27, 2021.
