Notice is hereby given that a public test of the ADA-compliant ballot marking devices to be used to mark central polling location ballots for the April 7, 2020 General Municipal Election held at the regular voting locations within Greene County, Missouri, will be held at 9:00 a.m., Wednesday, March 25, 2020 at the Greene County Elections Center, 1126 N Boonville Ave, Springfield, Missouri.

The digital scan voting equipment for tabulating absentee ballots for the April 7, 2020 General Municipal Election held at the regular voting locations within Greene County, Missouri, will be held at 9:00 a.m. Monday, February 24, 2020 at the Greene County Elections Center, 1126 N Boonville Ave, Springfield, Missouri. The digital scan voting equipment for tabulating ballots for the April 7, 2020 General Municipal Election held at the regular voting locations within Greene County, Missouri, will be held at 9:00 a.m., Thursday, March 26, 2020 and will continue until complete on Friday, March 27, 2020 at the Greene County Elections Center, 1126 N Boonville Ave, Springfield, Missouri. The purpose of said public tests is to ascertain that the equipment will correctly count the votes cast on all measures, and shall be open to the press and the public. The tests shall be conducted by processing a pre-audited group of ballots so marked as to record a predetermined number of valid votes on each measure and for each candidate, and shall include one or more ballots which have votes in excess of the number allowed by law in order to test the ability of the automatic tabulating equipment to reject such votes. If any error is detected, the cause therefore shall be ascertained and corrected and an errorless count shall be made before the automatic tabulating equipment is approved.

A posttest of the digital scan voting equipment for tabulating ballots of the April 7, 2020 General Municipal Election will be held at 9:30 a.m., Thursday, April 9, 2020 and Friday, April 10, 2020 at the Greene County Elections Center, 1126 N Boonville Ave, Springfield, Missouri.

The March 25, 2020 through March 27, 2020 tests HAVE BEEN POSTPONED until further notice per the Southern Appellate Court decision SD 36598. The posttest held on April 9, 2020 and April 10, 2020 HAVE ALSO BEEN POSTPONED until further notice per the Southern Appellate Court decision SD 36598.
