

2020 Summary

- **4062 calls** reporting deaths to Medical Examiner's Office; investigators on call 24/7 to receive calls and respond to scenes
- 868 death certificates signed
- 48 toxicology only cases
- 331 postmortem examinations
 - o 214 full autopsies
 - o 99 external examinations
 - o 18 partial autopsies
 - 282 autopsy equivalents (considers 2 external examinations equivalent to the work of 1 autopsy)
- Turnaround time for postmortem reports
 - o 28 days average completion time
 - o 92.7% of reports completed within 60 days
 - o 96.7% of reports completed within 90 days
