#### QUESTION

Shall Greene County Reorganized School District No. 3 (Republic) issue its general obligation bonds in the amount of \$5,000,000 for the purpose of constructing, furnishing and equipping an activities facility, resulting in no estimated increase to the debt service tax levy?

If this proposition is approved, the District's debt service levy is estimated to remain unchanged at \$0.9400 per one hundred dollars assessed valuation of real and personal property.





If this proposition is approved, the District's debt service levy is estimated to remain unchanged at \$0.9800 per one hundred dollars assessed valuation of real and personal property.


