The April 20, 2017 LEPC General Membership meeting was called to order by Vice-Chair, Russ Conroy at 12:05 p.m.

Russ presented the February 23, 2017 LEPC General Membership minutes. Zim made a motion to approve the minutes as presented. J D Landon seconded the motion. A vote was held and the minutes were approved.

OLD BUSINESS

Larry Woods provided the Financial Statement Report for the LEPC. To-date we have spent \$15,097.46 of the total \$27,159.27 budget. Hard copies of the Treasurer's Report were made available to those that wanted one to review and will be posted on-line.

No MERC update was provided.

John gave the regional HAZMAT and WMD Planning Update. There were a few small fuel spills reported since the last meeting. Cyber-attacks are becoming a higher priority to guard against as well as social media attacks. The NORSE Map is a good tool to review.

Samantha Foster (Peterson) gave the TEPW and Training update. ICS 300 class will be April 25 – 27; Basic Infectious Disease Training for Law Enforcement May 12; ICS 400 May 16-17th; Ignitable Liquids and Class B Foams Sept. 9; and ICS 300 and 400 in August and Sept. Members were reminded that upcoming training opportunities can be signed up for from the SEMA website.

Samantha gave the CERT update. Twenty-three graduates April 25th from MSU CERT class. The spring 2017 Public CERT class will start on Saturday with 35 enrolled. There will be a new CERT class offered this summer in the evening hours. So far in 2017 CERT volunteers have logged 175 hours at the Safe and Sound event, Severe Weather Expo and deployed to Goodman, Missouri.
