Samantha gave the CERT update. CERT fall classes are done now with 9 graduating. Spring classes are set (April 21 and May 5 start dates) and open for enrollment now. CERT volunteers have continued to work at local large scale events such as Bass Pro Marathon, Pets and Pumpkins, City Utilities Safety Days, etc.
