Greene County Collector, Assessor, and Clerk's statements on 2021 taxes

SPRINGFIELD, Mo. – Allen Icet, Brent Johnson, and Shane Schoeller joined together on the Greene County Historic Courthouse steps Tuesday November 9th, to give an update on 2021 personal property and real estate tax statements.

Digital tax statements are now available online at www.CountyCollector.com. Each officeholder reiterated the successful collaborative process that ensured 2021 tax statements are accurate and on time.

“2020 was a difficult year that presented unique challenges for our office, not only for tax administration, but also for administering a safe and secure election. In spite the enormity of the challenges presented, all our county officeholders and their office teams worked hard to serve our fellow taxpayers of Greene County,” said Greene County Clerk Shane Schoeller.

“The collective challenges presented in 2020 in presenting a balanced tax book to the Collector, due to the transition to new software, created a collective commitment by all past and present to improve the process going forward. This year, with new officeholders and support staff, and a spirit of collegiality, we have really turned things around, and have worked together effectively to serve Greene County taxpayers.

Due in no small part to this collaboration and hard work, the Clerk’s office was able to meet its statutory deadline and deliver a tax book on time. At this time, we believe it is being delivered with the accuracy standard we all strive to meet in our offices respectively and has taken place traditionally via each office during tax administration time.

I want to thank our team members, as well as Allen and Brent and their team members for their professionalism and hard work to help make this possible and encourage taxpayers to reach out if you have questions and we will be pleased to assist.”

Greene County Assessor, Brent Johnson, said, “I assumed office on September 1st and immediately took steps to conduct an internal review of processes and workflows within the Assessor Office to ensure the 2021 Personal and Real Property Assessments were conducted in accordance with statute, while ensuring the assessed values to be fair and equitable. This review resulted in the implementation of new processes to bring greater accuracy, efficiency, and enhanced customer service to the taxpayer.

I would like to express my appreciation for my colleagues County Clerk Shane Schoeller and Collector Allen Icet, and their respective staff, for their tireless work and collaboration in completing the 2021 Assessment year. My office oversees 121,486 Parcels with an assessed value of \$4.6 billion (\$67 million in New Construction) and over 350,000 Individual & Business Personal Property assets with an assessed value of more than \$1 billion. The Personal and Real Property total is more than \$5.6 billion.
