

OSCA – PREA data

The Prison Rape Elimination Act (PREA) requires all state agencies to collect data for every allegation of sexual abuse at facilities under its direct control. The agency shall aggregate the data annually. The following Juvenile Court Secure Detention facility data related to sexual abuse for calendar year 2014
