# 9-1-1 Advisory Board Meeting August 10, 2016

**1. CALL TO ORDER** – The Greene County 9-1-1 Advisory Board was called to order by Chair David Hall on August 10, 2016 at approximately 3:00 p.m. in the Public Safety Center, 911 Emergency Communications conference room at 330 W. Scott Street, Springfield, MO 65802. Seven board members were in attendance. *Attendance details in Attachment*.

**2. APPROVAL of the June 24, 2016 Special Meeting Minutes and July 27, 2016 – Hall** indicated a draft of the meeting minutes were distributed to the board members for review prior to the meeting. Williams motioned to approve the minutes for the June 24, 2016 special meeting as corrected. Fisk seconded. Motion carried 7/0. Fisk motioned to approve the minutes for the July 27, 2016 monthly meeting. Coulter seconded. Motion carried 7/0.

### 3. STATUS UPDATES

**A. Financial Reports - Jeff Scott** (via phone), Greene County Budget Officer, distributed the June 2016 financial reports. Sales tax revenue for June was at a low volume with 20 of the top 50 remitters being unprocessed. However, revenue is on pace with budget while expenses are behind pace at only 45.29% of budget. Our one time large items, such as Springfield General Liability and Overhead have not been charged yet but are offset by items such as CAD Maintenance that is for a full year. Professional Fees is \$33,234 ahead of budget but this represents the staffing study and is covered by contingency. Cash balance is at \$3,362,925 as of 6/30/2016. This is \$1,065,826 higher than this time last year.

### 4. OLD BUSINESS

**A. Emergency Communications Department Update – Schwartze** passed out the monthly Atta's and indicated there were two external complaints. One complaint was sustained and one for rudeness was unfounded after investigation.

B. P1CAD and Statistics Update - Webb viewed the updates on July's dashboard

**C. 2017 Budget** – **Vote** Schwartze adjusted several categories upon Board request after July's presentation. The revised budget was handed out to all Board members for final review. Williams motioned to approve the 2017 Springfield Greene County 9-1-1 Emergency Communications Budget. Prewitt seconded. Motion carried 7/0.

**6. ADJOURNMENT** -- With no further business to discuss, the meeting was adjourned at approximately 3:31 p.m. Fisk motioned to adjourn, Coulter seconded. Motion carried 7/0.
