9-1-1 Advisory Board Meeting April 17, 2019

- CALL TO ORDER The Greene County 9-1-1 Advisory Board was called to order by Chair Williams on April 17, 2019 at 3:00 p.m. in the Public Safety Center, 9-1-1 Conference room at 330 W. Scott Street, Springfield, MO 65802. Eight board members and proxies were in attendance. *Attendance details in Attachment*.
- 2. APPROVAL March 20, 2019 Meeting Minutes Williams indicated a draft of the meeting minutes were distributed to the board members for review prior to the meeting. Pennington motioned to approve the minutes, Wade seconded. Motion carried 8/0.

3. STATUS UPDATES

Financial Reports - Jeff Scott, representing the Greene County Budget Office, presented the February Financial reports. February represents 16.67% of the year. Revenues are running slightly ahead of this pace. We are seeing signs that indicate the State is catching up on processing delays. Overall expenditures were 12.27% of budget. Personnel expenditures were 13.98% of budget leaving a vacancy on pace to \$450,186.28. This is well over the budgeted vacancy of \$276,000. Actual operations were 5.94% of budget. When making adjustments for one-time expenses (Gen Liab, Tele, Spfd All OvrHd, CAD Sys Maint) expenses are 8.33% of budget. Capital, Debt Service & Contingency was 0% of budget with no spending. With contingency removed Adjusted Overall Budget is \$931,268.09 and Adjusted Overall Spending is \$831,090.44 for a \$100,177.65 volume to the good. Cash balance at 2/28/19 consisted of the \$300,000.00 equipment reserve and \$3,973,184 in the warrant account. This is \$688,180 higher than last year. Uncleared checks total \$363,714. This leaves a net cash value of \$3,909,470. Cash level is 2.62 times larger than required operating reserve level of \$1,490,156.

- **B. P1CAD and Statistics Update –Webb** The March and Year-to-Date 9-1-1 Reports were provided. Webb noted the text-to-9-1-1 calls went up slightly. He stated there were 21,000 9-1-1 calls last month and the number of calls went down slightly.

5. NEW BUSINESS

- **A. Springfield Cardinals Game-** Schwartze noted the Springfield Cardinals Game for the 9-1-1 Advisory Board will be held on June 27, 2019. Tickets will be provided at a later meeting.
- **B.** National Telecommunicators Week-April 14-20, 2019- Schwartze noted National Telecommunicators Week is currently going on. She stated there have been a lot of fun activities held and thanked the agencies who have brought in food for the floor.
- **6. ADJOURNMENT --** With no further business to discuss, the meeting was adjourned at approximately 3:23 p.m. Pennington motioned to adjourn, Coulter seconded. Motion carried 8/0.
