9-1-1 Advisory Board Meeting April 15, 2020

- 1. CALL TO ORDER The Greene County 9-1-1 Advisory Board was called to order by Chair Williams on April 15, 2020 at 3:00 p.m. via phone conference call. Eight board members were in attendance. *Attendance details in Attachment*.
- 2. APPROVAL February 19, 2020 Meeting Minutes Williams indicated a draft of the meeting minutes were distributed to the board members for review prior to the meeting. Pennington motioned to approve the minutes; Quigley seconded. Motion carried 8/0.

3. STATUS UPDATES

Financial Reports - The written report for the February Financials were read into the monthly meeting. February represents 16.67% of the year. Sales Tax is currently on pace. Transfers are 104% of budget and include the early pay-off of the Recovery Bond, only a small transfer for OEM secretarial services remains for this year. Overall expenditures were 11.68% of budget. Personnel expenditures were 14.13% of budget leaving a vacancy on pace to \$815,900.16. This is well over the budgeted vacancy of \$400,000. Actual operations were 8.42% of budget. Uniform Allowance is over budget and Utilities, Professional Services, Springfield Plaza TIF, Training & Meetings, and Network Line are ahead of pace. Capital, Debt Service & Contingency were 0.40% of budget. When making adjustments for one-time expenses (Gen Liab, Tele, Spfd All OvrHd, CAD Sys Maint) expenses are 13.42% of budget. With contingency removed Adjusted YTD Overall Budget is \$1,116,308.70 and Adjusted Overall YTD Spending is \$901,106.28 for a \$215,202.41 volume to the good. Cash balance at 02/29/20 was \$1,560,644 in the warrant account. This is \$2,712,540 lower than last year. Uncleared checks at month-end totaled \$0. This leaves a net cash value of \$1,560,644. Net cash level is 0.95 times of the required operating reserve level of \$1,651,109. With the current pace of savings to budget the net fund balance is expected to exceed the operating reserve level next month.

Quigley motioned to approve the February financial report, Coulter seconded. Motion carried 8/0.
