9-1-1 Advisory Board Meeting May 20, 2020

- CALL TO ORDER The Greene County 9-1-1 Advisory Board was called to order by Chair Williams on May 20, 2020 at 3:00 p.m. in the Public Safety Center, 9-1-1 Conference room at 330 W. Scott Street, Springfield, MO 65802. Six board members and proxies were in attendance. *Attendance details in Attachment*.
- 2. APPROVAL –April 15, 2020 Meeting Minutes Williams indicated a draft of the meeting minutes were distributed to the board members for review prior to the meeting. Moore motioned to approve the minutes; Wade seconded. Motion carried 6/0.

3. STATUS UPDATES

Financial Reports - The written report for the March Financials were presented by Budget Officer Jeff Scott. March represents 25% of the year. Sales Tax is currently on pace and the impact from COVID-19 is not expected to be seen until the May financials. Current budget estimates are that sales tax will end \$327,000 below budget. The Treasurer estimates that interest figures will be half of budget. Fees on prepaid phones are currently expected to be \$60,000 below budget. Transfers are 104% of budget and include the early pay-off of the Recovery Bond, only a small transfer for OEM secretarial services remains for this year. Transfers are expected to be \$128,000 below budget. In total revenues are expected to be \$565,000 below budget at yearend. Overall expenditures were 17.39% of budget. Personnel expenditures were 20.89% of budget leaving a vacancy on pace to \$481,014.47 better than budget of \$400,000. Actual operations were 13.43% of budget. Uniform Allowance is over budget and Utilities, Springfield Plaza TIF, Equipment Lease, Building Maintenance, Office Supplies, and Network Line are ahead of pace. Capital, Debt Service & Contingency were 0.40% of budget. When making adjustments for one-time expenses (Gen Liab, Tele, Spfd All OvrHd, CAD Sys Maint, Equipment) expenses are 18.57% of budget. With contingency removed Adjusted YTD Overall Budget is \$1,581,637.15 and Adjusted Overall YTD Spending is \$1,246,983.39 for a \$334,653.76 volume to the good. Expense savings, in particular personnel and equipment, are expected to exceed declines in revenue. Cash balance at 03/31/20 was \$2,160,710 in the warrant account. This is \$2,306,525 lower than last year. Uncleared checks at month-end totaled \$793,141. This leaves a net cash value of \$1,367,570. Net cash level is 0.83 times of the required operating reserve level of \$1,651,109. With the current pace of savings to budget the net fund balance is expected to exceed the operating reserve level by the end of the year.

4. OLD BUSINESS

- A. P1CAD and Statistics Update –Assistant Director Webb The April and Year-to-Date 9-1-1 Reports were provided. Webb noted the Springfield-Greene County 9-1-1 call takers are currently at 92% of the calls answered in ten seconds. He stated total calls were down 11.8%, CAD incidents were down 25%, Fire calls were down 50% and Law calls were down 36%.
- **B.** 9-1-1 Grant –Assistant Director Webb Webb noted next generation 9-1-1 will cost roughly \$100,000 in upgrades to our 911 phone equipment, however monthly costs will double at \$44,000 a month. He stated the grant is on hold for the time being.

5. NEW BUSINESS

- **A. Introduction of Director Kris Inman** Quigley introduced the new Springfield-Greene County 9-1-1 Emergency Communications Director Kris Inman.
- **6. ADJOURNMENT --** With no further business to discuss, the meeting was adjourned at approximately 3:20 p.m. Pennington motioned to adjourn, Mericle seconded. Motion carried 6/0.
