9-1-1 Advisory Board Meeting July 15, 2020

- CALL TO ORDER The Greene County 9-1-1 Advisory Board was called to order by Chair Williams on July 15, 2020 at 3:00 p.m. via phone conference call. Eight board members and proxies were in attendance. *Attendance details in Attachment*.
- 2. APPROVAL –June 17, 2020 Meeting Minutes Williams indicated a draft of the meeting minutes were distributed to the board members for review prior to the meeting. Pennington motioned to approve the minutes; Wade seconded. Motion carried 8/0.

3. STATUS UPDATES

Financial Reports - The written report for the May Financials were presented by Budget Officer Jeff Scott. May represents 42% of the year. Sales Tax is only 1 1/2% behind pace. New budget estimates are that sales tax will end \$244,275 below budget as opposed to the previous estimate of \$327,000 below budget. The Treasurer estimates that interest figures will be half of budget. Fees on prepaid phones are currently expected to be \$60,000 below budget. Transfers are 104% of budget and include the early pay-off of the Recovery Bond, only a small transfer for OEM secretarial services remains for this year. Transfers are expected to be \$128,000 below budget. In total revenues are expected to be \$482,275 below budget at year-end. Overall expenditures were 37.57% of budget. Personnel expenditures were 37.29% of budget leaving a vacancy on pace to \$602,611 better than budget of \$400,000. Actual operations were 67.70% of budget. Uniform Allowance is over budget and Utilities, Springfield Plaza TIF, network Line, Building Maintenance, and Office Supplies, are ahead of pace. The annual charges for Springfield Allocated Overhead and CAD System Maintenance hit this month. Capital, Debt Service & Contingency were 0.40% of budget. When making adjustments for one-time expenses (Gen Liab, Tele, Spfd All OvrHd, CAD Sys Maint, Equipment) expenses are 32.34% of budget. With contingency removed Adjusted YTD Overall Budget is \$2,830,907 and Adjusted Overall YTD Spending is \$2,171,444 for a \$659,463 volume to the good. Expense savings, in particular personnel and equipment, are expected to exceed declines in revenue. Cash balance at 05/31/20 was \$2,079,584 in the warrant account. This is \$2,539,232 lower than last year. Uncleared checks at month-end totaled \$496,710. This leaves a net cash value of \$1,582,874. Net cash level is 0.96 times of the required operating reserve level of \$1,651,109. With the current pace of savings to budget the net fund balance is expected to exceed the operating reserve level by the end of the year. Next month cash balance is expected to be the low of the year with the expenses for CAD maintenance and Springfield Allocated Overhead coming out of cash.

- **C. Board Appointments Inman** Inman noted the current vacancy for the Member-At-Large position is posted and we should be receiving applications shortly.
