9-1-1 Advisory Board Meeting January 20, 2021

- 1. CALL TO ORDER The Greene County 9-1-1 Advisory Board was called to order by Vice Chair Moore on January 20, 2021 at 3:00 p.m. via phone conference call. Nine board members and proxies were in attendance. *Attendance details in Attachment*.
- 2. APPROVAL –December 16, 2020 Meeting Minutes Moore indicated a draft of the meeting minutes were distributed to the board members for review prior to the meeting. Pennington motioned to approve the minutes; Denison seconded. Motion carried 9/0.

3. STATUS UPDATES

Financial Reports - The written report for the November Financials were presented by Assistant Director J.R. Webb. November represents 92% of the year. Sales Tax is ahead of pace and is expected to finish the year \$182K over budget. Interest figures will be \$64K behind budget. Fees on prepaid phones are \$74K below budget. Transfers are 104% of budget. Transfers are expected to be \$125,000 below budget. In total revenues are expected to be \$81,000 below budget at year-end. Overall expenditures were 74% of budget. Personnel expenditures were 82% of budget leaving a vacancy on pace to \$579,833.96, better than budget of \$400,000. Actual operations were 95% of budget. Uniform Allowance, Telephone, Professional Services, Dues & Subscriptions, Building Maintenance, and Office Supplies are over budget with 1 month remaining. Utilities, Springfield Plaza TIF, and Network Line are ahead of pace. Capital, Debt Service & Contingency remain 0.40% of budget. When making adjustments for one-time expenses (Gen Liab, Tele, Spfd All OvrHd, CAD Sys Maint, Equipment) expenses are 71% of budget. With contingency removed Adjusted YTD Overall Budget is \$6,187,644.41 and Adjusted Overall YTD Spending is \$4,771,645.51 for a \$1,415,998.90 volume to the good. This is very favorable to the \$81,000 estimated decline in Revenues.

Cash balance at 11/30/20 was \$2,074,583 in the warrant account. This is \$2,635,627 lower than last year. Uncleared checks at month-end totaled \$1,227. This leaves a net cash value of \$2,073,355. Net cash level is 1.26 times of the required operating reserve level of \$1,651,109.

- **B.** P1CAD and Statistics Update –Webb Webb noted calls are slightly up and that response times are down due to staffing issues due to COVID-19.
- C. 2020 Year-End Statistics Inman and Webb Inman noted turnover for the entire department in 2020 was 10.5%, the lowest it has been in 18 years. Webb noted we received just over 500,000 calls in 2020 with wireless calls going up.
