**Treasurer's Report:** Chuck Marinec presented the Treasurer's Report for Monica Horton as of October 31, 2020 compiled by Cindy Stein, County Auditor (see attached). Total Cash Balance \$1,353,758.82. Property Tax Revenue of \$0.00, Bank/Investment Interest \$1,418.00, Refunds & Reimbursements of \$470.39 with a Total Revenue of \$2,336,649.02. Total Expenditures \$2,170,669.27. Total Ending Balance \$1,521,738.57. Total checks issued: Deborah Allen (3), Arc of the Ozarks, Legal Services Southern Mo, Clay County Senior Services, Mercy Regional Health, Springfield Park Board, Jordan Valley Health and Senior Age Area Agency on Ageing (3<sup>rd</sup> & 4<sup>th</sup> Quarter). Total amount of checks issued \$697,468.37.

#### Presentation: United Way Give 5, Greg Burris

Greg Burris gave a brief presentation detailing what is covered by United Way Give 5. The application amount requested is 33,554.00.

Chuck Marinec noted all progress reports are due by January 31, 2021. The Board will make every effort to process in a timely manner. However, all reports must be in and approved by a member of the Board prior to the actual release of funds.
