# 9-1-1 Advisory Board Meeting March 17, 2021

- 1. CALL TO ORDER The Greene County 9-1-1 Advisory Board was called to order by Chair Moore on March 17, 2021 at 3:01 p.m. via phone conference call. Eight board members and proxies were in attendance. *Attendance details in Attachment*.
- 2. APPROVAL –February 17, 2021 Meeting Minutes Moore indicated a draft of the meeting minutes were distributed to the board members for review prior to the meeting. Wade motioned to approve the minutes; Williams seconded. Motion carried 8/0.

# 3. STATUS UPDATES

**Financial Reports** - The written report for the January Financials were presented by Budget Officer Jeff Scott. January represents 8% of the year. Sales tax is at 7.5% of budget, with January being a month that is traditionally below average. Overall revenues were 7.26% of budget. Overall expenditures were 6% of budget. Personnel expenditures were 7% of budget leaving vacancy on pace for \$549,379, better than budget of \$275,000. Actual operations are 3.5% of budget. Utilitities, telephone, Springfield Plaza TIF, network line, and office supplies are ahead of pace. Capital, Debt Service & Contingency are 0.67% of budget. When making adjustments for one-time expenses (Gen Liab, Tele, Spfd All OvrHd, CAD Sys Maint, Equipment) expenses are 7.3% of budget. With contingency removed Adjusted YTD Overall Budget is \$529,314.65 and Adjusted Overall YTD Spending is \$428,418.55 for a \$100,896.10 volume to the good. Cash balance at 1/31/21 was \$2,966,760.44 in the warrant account. This is \$730,728 lower than last year. Uncleared checks at month-end totaled \$4,741. This leaves a net cash value of \$2,962,019. Net cash level is

1.78 times the required operating reserve level of \$1,665,031. Note: Slow processing of the January 2021 Springfield invoice has \$403,378.60 in expenses not represented in the outstanding warrants yet.

# 4. OLD BUSINESS

- A. Center Update –Inman Inman noted there had been no COVID cases within the department in a month. He stated four new employees will be starting on the 29th. Inman noted training for Lead Telecommunicators have began a program for mentoring new hires along with creating annual training for Code 3 and Fire Mayday training.
- **B. P1CAD and Statistics Update –Webb** Webb noted 91.7% of calls are being answered within 15 seconds. He stated NENA recently updated their standard from 10 seconds to 15 seconds. Webb noted the radio is currently being installed.
- **C. CALEA Update –Inman** Inman noted the accreditation process with CALEA has ended due to a review of standards regarding the hiring process for new telecommunicators that would involve a costly hiring process, including psychological evaluations. He stated although the accreditation had not been complete, the department had received many benefits from the process including a review of all standard operating guidelines and streamlining processes.

# 5. NEW BUSINESS

- **A. National Telecommunicators Week Cunningham** 9-1-1 Executive Secretary Megan Cunningham noted National Telecommunicators Week is scheduled for April 11<sup>th</sup> through the 17<sup>th</sup>. She stated many fun activities are planned for the week and thanked the user agencies for their food donations during the week.
- **6. ADJOURNMENT --** With no further business to discuss, the meeting was adjourned at approximately 3:41 p.m. Coulter motioned to adjourn, Quigley seconded. Motion carried 8/0.
