9-1-1 Advisory Board Meeting June 16, 2021

- 1. CALL TO ORDER The Greene County 9-1-1 Advisory Board was called to order by Chair Moore on June 16, 2021 at 3:00 p.m. via phone conference call. Seven board members and proxies were in attendance. *Attendance details in Attachment*.
- 2. APPROVAL –April 21, 2021 Meeting Minutes Moore indicated a draft of the meeting minutes were distributed to the board members for review prior to the meeting. Denison motioned to approve the minutes; Williams seconded. Motion carried 7/0.

3. STATUS UPDATES

Financial Reports - The written report for the April Financials were presented by Budget Officer Tina Phillips. April represents a third of the year. Revenues are right on pace. Note that 911 Service charge is at 40.81% of budget, with how these quarterly payments come in we would expect to be at 50% of budget now. The 30k that we are behind in 911 Service Charge is expected to be offset by higher future Sales Tax receipts. Overall expenditures were 31% of budget. Personnel expenditures were 29% of budget leaving vacancy on pace for \$225,959. Actual operations are 48.48% of budget. Primarily due to the annual cost of CAD system Maintenance and County General Liability being paid. General Liability, utilities, telephone, Springfield Plaza TIF, network line, CAD system maintenance, and office supplies are ahead of pace. Capital, Debt Service & Contingency are 0.67% of budget. When making adjustments for one-time expenses (Gen Liab, Tele, Spfd All OvrHd, CAD Sys Maint, Equipment) expenses are only 26.67%% of budget. With contingency removed Adjusted YTD Overall Budget is \$2,114,149.32 and Adjusted Overall YTD Spending is \$1,800,813.88 for a \$313,335.44 volume to the good.

Cash balance at 4/30/21 was \$3,636,303 in the warrant account. This is \$2,052,975 higher than last year. Uncleared checks at month-end totaled \$823,820. (Springfield's March billing, including CAD maintenance) This leaves a net cash value of \$2,812,483. Net cash level is 1.19 times the required operating reserve level of \$1,665,031.

- A. Meeting Update–Inman Inman noted with COVID numbers going down and vaccinations becoming readily available, he asked the board about meeting in person. After a brief discussion, Denison made a motion to meet in July for the budget presentation and again in December for Christmas, Coulter seconded. Motion carried 7/0.
- **6. ADJOURNMENT --** With no further business to discuss, the meeting was adjourned at approximately 3:18 p.m. Quigley motioned to adjourn, Coulter seconded. Motion carried 7/0.
