9-1-1 Advisory Board Meeting November 17, 2021

- 1. CALL TO ORDER The Greene County 9-1-1 Advisory Board was called to order by Chair Moore on November 17, 2021 at 3:00 p.m. via phone conference call. Nine board members were in attendance. *Attendance details in Attachment*.
- 2. APPROVAL –October 20, 2021 Meeting Minutes Moore indicated a draft of the meeting minutes were distributed to the board members for review prior to the meeting. Denison motioned to approve the minutes; Schrader seconded. Motion carried 9/0.

3. STATUS UPDATES

Financial Reports - The written report for the September Financials were presented by Budget Officer Jeff Scott. Revenues are 92% of budget at 75% through the year. 911 Service Charge is slightly behind budget. 911 Service Charge is still expected to be \$30,000 behind budget and Interest income is behind by another \$17,500, Sales Tax receipts are expected to make up those shortfalls. Overall expenditures were 68% of budget. Personnel expenditures were 69% of budget leaving vacancy on pace for \$526,481. Actual operations are 78% of budget. Primarily due to the annual cost of CAD system Maintenance, General Liability, and Springfield Allocated Overhead being paid. Uniform Allowance, General Liability, Utilities, telephone, Springfield Plaza TIF, Springfield Allocated Overhead, Network line, CAD system maintenance, and office supplies are ahead of pace. Capital, Debt Service & Contingency remain 27% of budget. When making adjustments for one-time expenses (Gen Liab, Tele, Spfd All OvrHd, CAD Sys Maint, Equipment) expenses are only 6% of budget. With contingency removed Adjusted YTD Overall Budget is \$5,167,790 and Adjusted Overall YTD Spending is \$4,130,546 for a \$1,037,244 volume to the good.

Cash balance at 9/30/21 was \$4,191,504 in the warrant account. This is \$2,259,516 higher than last year. Uncleared checks at month-end totaled \$438,806. This leaves a net cash value of \$3,752,698. Net cash level is 2.25 times the required operating reserve level of \$1,665,031.

- **B. P1CAD and Statistics Update –Webb** Webb noted response times were down slightly due to current vacancies in the department.

5. NEW BUSINESS

A. Next Generation Contract –Inman and Webb – Inman noted the agency had recently signed the Next Generation contract and are moving forward to the next step of the process. Webb noted

they would be working on this process for the next 12-18 months. He stated this process has already been budgeted for and has been paid for through the county.

6. ADJOURNMENT -- With no further business to discuss, the meeting was adjourned at approximately 3:30 p.m. Coulter motioned to adjourn, Woods seconded. Motion carried 9/0.
