9-1-1 Advisory Board Meeting September 21, 2022

- 1. CALL TO ORDER The Greene County 9-1-1 Advisory Board was called to order by Chair Moore on September 21, 2022, at 3:00 p.m. via phone conference call. Eight board members were in attendance. *Attendance details in Attachment*.
- 2. APPROVAL –August 17, 2022, Meeting Minutes Moore indicated a draft of the meeting minutes were distributed to the board members for review prior to the meeting. Denison motioned to approve the minutes; Williams seconded. Motion carried 8/0.

3. STATUS UPDATES

Financial Reports - The written report for the July Financials were presented by Budget Officer Jeff Scott. July represents 58% of the year. Sales tax is at 71.24% of budget with 911 Service Charge at 67.24% and Investment Interest exceeding well over budget at 2,332.57%. Overall revenue is coming in ahead of budget at 71.81%. This is currently \$1,106,660 ahead of pace. Sales tax is projected to finish \$820,000 higher than budget. Personnel expenditures were 56.4% of budget, compared to 57.7% for 15 of 26 pay periods with projected vacancy to be 116,106 better than budget of \$275,000. Operations are 70.7% of budget with general liability, utilities, Springfield allocated overhead, CAD system maintenance and office supplies ahead of pace. Capital, Debt Service and Contingency are at 63.3% with equipment coming in at 105.7%. Overall, total expenditures are running below pace at 59.5%. When making adjustments for one-time expenses (Gen.Liability, Telephone, Spfld All OvrHd, CAD System Main, Equipment), expenses are 55.8% of budget. Adjusted YTD Overall Budget is \$4,152,413 and Adjusted Overall YTD Spending is \$3,863,917 for a \$288,497 volume to the good through 7 months.

Cash balance at 7/31/22 was \$6,255,144 in the warrant account. This is \$2,384,798 higher than last year. Net cash level is 3.76 times the required operating reserve level of \$1,665,031. Budgeted Revenues are \$1,034,156 higher than Budgeted Expenditures. Sales tax is expected to be \$820,000 higher than budget and annualized expenditures are estimated to be \$495,841 better than budget. This indicates an almost \$2,350,000 added to beginning cash balance this year of \$4,532,011 for a total projected ending cash balance of \$6,882,000. This ending amount represents 4.13x coverage of the 2022 required operating reserve.

4. OLD BUSINESS

- A. Center Update –Inman Inman noted there are currently 17 new employees in training. He stated there are 10 vacancies and will have one final posting this year on October 14, 2022. Inman noted the new GIS Specialist has officially started.
- **B. P1CAD and Statistics Update –Webb** Webb noted 92.3% of calls are being answered within 15 seconds. He stated there is a hardware refresh coming soon for CAD. Webb noted we will soon be receiving ADT alarms via text.

5. NEW BUSINESS

- **A.** New Projects –Inman Inman noted the department has been working diligently to select new projects to utilize excess contingency funds.
- **6. ADJOURNMENT --** With no further business to discuss, the meeting was adjourned at approximately 3:27 p.m. Denison motioned to adjourn, Arnott seconded. Motion carried 8/0.
