#### Timing of Revenues

- Start assessing the first full quarter after the tax is passed.
- First full quarter is January 1, 2018 to March 31, 2018
- Tax begins April 1, 2018 I'm not fool'in
- We expect to see ≈\$215,000 in May, ≈\$1,870,500 in June, and ≈\$2,150,000 every month after.
  ≈\$17,135,500 for 2018 and ≈\$25,800,000 annually

### Salary Restructure



- GR 2 was not used for the Salary restructure.
- Needed to have a salary structure that was sustainable and get positions to market value.
- This allowed for more steps within the grade instead of maxing out in 10 years.
