# 9-1-1 Advisory Board Meeting August 16, 2023

- 1. CALL TO ORDER The Greene County 9-1-1 Advisory Board was called to order by Chair Pennington on August 16, 2023, via phone conference call. Nine board members were in attendance. *Attendance details in Attachment*.
- 2. APPROVAL –June 21, 2023 Meeting Minutes Pennington indicated a draft of the meeting minutes were distributed to the board members for review prior to the meeting. Woods motioned to approve the minutes; Coulter seconded. Motion carried 8/0.

## 3. STATUS UPDATES

**Financial Reports** - The written report for the June Financials were presented by Budget Officer Jeff Scott. June represents 50% of the year. Sales tax is behind pace at 47.89%. Bank and Investment Interest are ahead of pace. Overall, revenue is ending the month behind pace at 48.51%. Personnel expenditures were 46% compared to 13 of 26 pay periods being 50%. Vacancy is on pace to be \$509,569.30 better then budget of \$275,000. Operations is ahead of pace at 64%. CAD System Maintenance and Springfield Allocated Overhead are the major contributors to this situation. When you combine Personnel & Operations, expenditures are at pace at 50%. Capital, Debt Service and Contingency is at 18%. Overall, total expenditures are better than pace at 44%. When making adjustments for one-time expenses (Gen.Liability, Telephone, Spfld All OvrHd, CAD System Maint, Equipment), expenses are 39% of budget. Adjusted YTD Overall Budget is \$4,734,268 and Adjusted Overall YTD Spending is \$3,730,122 for a \$1,004,146 volume to the good through 6 months.

Cash balance at the end of June 2023 was \$7,804,661 in the warrant account. This is \$1,725,645 higher than last year. Cash level is 3.76 times the required operating reserve level of \$1,928,537.

## 4. OLD BUSINESS

- **A.** Center Update Webb Webb noted they will be posting the 911 Telecommunicator vacancy on September 5<sup>th</sup>. He stated the console update and carpet project had been completed.
- **B. P1CAD and Statistics Update –Webb** Webb noted 91.1% of calls are being answered within 15 seconds.

## 5. NEW BUSINESS

A. Budget Presentation and Approval – Ford – Ford presented the 2024 County Budget proposal to the 9-1-1 Advisory Board. After a brief discussion, Jeff Scott from the Greene County Finance Department had made some adjustments to the line items.

Williams made a motion to approve the 2024 County Budget with the following adjustments to be made including increasing the telephone line to \$3,500, increasing the office supplies line to \$65,000, moving the \$25,000 from Building Reserve into unappropriated contingency and increase the sales tax revenue to \$9,387,000, Coulter seconded. Motion carried 8/0.

**6. ADJOURNMENT --** With no further business to discuss, the meeting was adjourned at approximately 3:40 p.m. Quigley motioned to adjourn, Denison seconded. Motion carried 8/0.
