Sales Tax Received in June 2024 (May 2024 processing)


County's General Sales Tax is <u>Up 1.65%</u> for this month compared to the same month in 2023 or <u>Up \$26,904</u> in 1984 voter approved General Fund portion and Up 1.26% year-to-date compared to the same period in 2023 or Up \$57,865 (March 2024 processing through February 2025 processing).

- Two of the top fifty remitters went unprocessed for an average total of \$10,067 and two of the previous six unprocessed did not catch up with more than twice their average amount for an average total of \$16,352. The top fifty remitters represent 45.16% of tax receipts.
- Current activity suggests 1984 voter approved General Fund portion of Sales Tax for 2024 will end the year at 18,639,382 which is at 95.41% of budget or \$896,347 below 2024 general revenue Fund 101 budget of \$19,535,729 and \$134,255 below 2023 actual.

Trend Lines

The 3-Month trend line increased 0.09% this month while the 12-Month line decreased 0.79% decreasing the gap to -2.78% from -3.74%. The trend lines crossed nineteen months ago. The upturn in the 3-Month trend line is encouraging. This is a possible signal of the immanent crossing of the trend lines signaling a transition from a period of a decline in growth to a period of increasing growth.

January and February continue to both have higher economic activity than the previous year (January becoming higher in the 4th month and February becoming higher in the 3rd month). March and April totals are still lower after 3rd and 4th months; while May is higher in this 1st month.
