Notice is hereby given that a public test of the digital scan voting equipment for tabulating absentee ballots for the August 6, 2024 General Primary Election held at the regular voting locations within Greene County, Missouri, will be held at 9:00 am, Friday, June 21, 2024 at the Greene County Historic Courthouse, 940 N Boonville Ave, RM 113, Springfield, Missouri.

The ADA-compliant ballot marking devices to be used to mark ballots for the August 6, 2024 General Primary Election held at the central polling locations within Greene County, Missouri, will be held at 9:00 a.m., Tuesday, July 16, 2024 at the Greene County Elections Center, 1126 N Boonville Ave, Springfield, Missouri. The ADA-compliant ballot marking devices to be used to mark ballots for the August 6, 2024 General Primary Election held at the regular voting locations within Greene County, Missouri, will be held at 9:00 a.m., Wednesday, July 17, 2024 at the Greene County Elections Center, 1126 N Boonville Ave, Springfield, Missouri.

The digital scan voting equipment for tabulating ballots for the August 6, 2024 General Primary Election held at the regular voting and central polling locations within Greene County, Missouri, will be held at 9:00 a.m., Thursday, July 18, 2024 and Friday, July 19, 2024 at the Greene County Elections Center, 1126 N Boonville Ave, Springfield, Missouri. The purpose of said public tests is to ascertain that the equipment will correctly count the votes cast on all measures, and shall be open to the press and the public.

The tests shall be conducted by processing a pre-audited group of ballots so marked as to record a predetermined number of valid votes on each measure and for each candidate, and shall include one or more ballots which have votes in excess of the number allowed by law in order to test the ability of the automatic tabulating equipment to reject such votes. If any error is detected, the cause therefore shall be ascertained and corrected and an errorless count shall be made before the automatic tabulating equipment is approved.

A posttest of the digital scan voting equipment for tabulating ballots of the August 6, 2024 General Primary Election will be held at 9:00 a.m., Thursday, August 8, 2024 and Friday, August 9, 2024 at the Greene County Elections Center, 1126 N Boonville Ave, Springfield, Missouri.
