9-1-1 Advisory Board Meeting November 15, 2023

- 1. CALL TO ORDER The Greene County 9-1-1 Advisory Board was called to order by Vice Chair Coulter on November 15, 2023, via phone conference call. Seven board members were in attendance. *Attendance details in Attachment*.
- 2. APPROVAL –October 18, 2023 Meeting Minutes Pennington indicated a draft of the meeting minutes were distributed to the board members for review prior to the meeting. Denison motioned to approve the minutes; Williams seconded. Motion carried 7/0.

3. STATUS UPDATES

Financial Reports - The written report for the August Financials were presented by Budget Officer Jeff Scott. September represents 75% of the year. Sales tax is behind pace at 73%. Bank and Investment Interest are ahead of pace. Overall, revenue is ending the month behind pace at 74%. Personnel expenditures were 68% compared to 19 of 26 pay periods being 73%. Vacancy is on pace to be \$439,034.43 better then budget of \$275,000. Operations is ahead of pace at 83%. CAD System Maintenance and Springfield Allocated Overhead are the major contributors to this situation. Office Supplies and Equipment Maintenance are over budget. When you combine Personnel & Operations, expenditures are better than pace at 71%. Capital, Debt Service and Contingency is at 43%. Overall, total expenditures are better than pace at 66%. When making adjustments for one-time expenses (Gen.Liability, Telephone, SpfId All OvrHd, CAD System Maint, Equipment), expenses are 63% of budget. Adjusted YTD Overall Budget is \$6,981,580.78 and Adjusted Overall YTD Spending is \$5,941,959.26 for a \$1,039,621.52 volume to the good through 9 months.

Cash balance at the end of September 2023 was \$8,227,953 in the warrant account. This is \$1,654,782 higher than last year. Cash level (less outstanding warrants) is 3.83 times the required operating reserve level of \$1,928,537.

- **B. P1CAD and Statistics Update –Webb** Webb noted 92.8% of calls are being answered within 15 seconds. He stated they are currently working on a CAD upgrade and CAD refresh.
