Sales Tax Received in September 2024 (August 2024 processing)


County's General Sales Tax is <u>Down 2.63%</u> for this month compared to the same month in 2023 or <u>Down \$44,475.74</u> in 1984 voter approved General Fund portion and <u>Up 1.31%</u> year-to-date compared to the same period in 2023 or <u>Up \$122,885.45</u> (March 2024 processing through February 2025 processing).

- Two of the top fifty remitters went unprocessed for an average total of \$34,281 and one of the previous four unprocessed did not remit balances close to twice their average this month for an average total of \$4,339. The top fifty remitters represent 48.20% of tax receipts.
- Current activity suggests 1984 voter approved General Fund portion of Sales Tax for 2024 will end the year at 18,850,835 which is at 96.49% of budget or \$684,894 below 2024 general revenue Fund 101 budget of \$19,535,729 and \$77,198 above 2023 actual. While this was the second month in a row that was down from last year, this month came in above average and improved the year-end projections.

Trend Lines

The 3-Month trend line <u>increased</u> 0.43% this month while the 12-Month line decreased 0.32% expanding the now positive gap from +0.05% to +0.80%. The trend lines crossed this month, as predicted. They last crossed twenty-one months ago. This crossing of the trend lines signals a transition from a period of a decline in growth to a period of increasing growth. Despite the disappointing numbers this month, this is a significant event.
