### Sales Tax Received in January 2025 (December 2024 processing)


County's General Sales Tax is <u>Down 6.35%</u> for this month compared to the same month in 2024 or <u>Down</u> <u>\$104,192.88</u> in 1984 voter approved General Fund portion and <u>Up 2.63%</u> year-to-date compared to the same period in 2024 or <u>Up \$404,810.65</u> (March 2024 processing through February 2025 processing).

- Five of the top fifty remitters went unprocessed for an average total of \$53,334 and all of the previous three unprocessed did not have balances close to twice their average this month for an average total of 11,524. The top fifty remitters represent 52.8% of tax receipts.
- Current activity suggests 1984 voter approved General Fund portion of Sales Tax for 2024 will end the year at 18,997,100 which is at 97.24% of budget or \$538,629 below 2024 general revenue Fund 101 budget of \$19,535,729 and \$223,463 above 2023 actual. However, the majority of this increase has occurred in the last 4 months. With the change in direction, the budget department believes the next 2 months should out-perform the same period last year and the result will be much closer to the budgeted amount.

## Trend Lines

The 3-Month trend line <u>increased</u> 0.52% this month and the 12-Month trend line <u>increased</u> 0.38% increasing the now positive gap from +3.37% to +3.50%. Both trend lines continue to indicate an increasing growth in sales tax related spending.
