Sales Tax Received in June 2025 (May 2025 processing)


County's General Sales Tax is <u>Up 9.36%</u> for this month compared to the same month in 2024 or <u>Up 155,535</u> in 1984 voter approved General Fund portion and **Up 3.30%** year-to-date compared to the same period in 2024 or **Up** \$153,858 (March 2025 processing through February 2026 processing).

- Five of the top fifty remitters went unprocessed for an average total of \$45,761 and three of the previous six unprocessed did not have balances close to twice their average this month for an average total of \$27,380. The top fifty remitters represent 53% of tax receipts.
- Current activity suggests 1984 voter approved General Fund portion of Sales Tax for 2025 will end the year at 19,316,866 which is at 94.89% of budget or \$1,039,384 below 2025 general revenue Fund 101 budget of \$20,356,250 and \$226,165 above 2024 actual.

Trend Lines

The 3-Month trend line increased 0.17% this month and the 12-Month trend line increased 0.42% decreasing the now positive gap from +1.51% to +1.26%. The trend lines continue to indicate an increasing growth in sales tax related spending. The 3-Month trend line has been moving up again, after moving sideways for the last few months.

We are continuing to see a larger volume of processing occurring earlier in 2025 than in 2024. This leads to an appearance of stronger volume in 2025, until the third and fourth month of processing occurs for an economic period. Concerns over the economy may have had a negative affect on consumer retail spending. As prices rise on basic necessities, sales tax is expected to increase.
