This addendum forms a part of the IFB document for the project identified above. All remaining portions of the IFB document not specifically mentioned or otherwise revised by this addendum or previous addenda remain in full force and effect.

Clarification

1. Section 5- Bid Specifications, subsection 8.2 has been revised to:
The storage facility shall be enclosed by a fence of no less than six (6) feet in height, with fencing that cannot be easily traversed. In areas where there is chain link, there must be three (3) strands of barbed wire surrounding the top of the fence at 6-inch (6") intervals. All gates to the fenced area must be secured by a padlock or similar locking device at all times when work is not being performed in the enclosure by authorized personnel. The enclosure must be reasonably lighted during the hours of darkness so as to discourage tampering and thefts from stored vehicles. The surface of the compound must be at least graveled. The storage facility shall be monitored by a video surveillance system in such a way as to monitor the entire facility from all four corners, of each storage lot. The video system must be capable of 24-hour video recording. All recordings must be kept for 30 days, before reuse or disposal.
Added the specification of- fencing that cannot be easily traversed, and barbed wire is required only where there is chain link.
2. Site Inspection- You will be contacted within 1-2 weeks of the bid opening for Greene County Sheriff's Office employees to come do a site inspection.

Each bidder shall acknowledge receipt of this Addendum #1 of Invitation for Bid #25-11094 titled IFB Custody Towing & Storage Services with his/her signature affixed hereto; and shall submit this signed acknowledgement and any attachments provided herein with their original bid submittal.
