#### Sales Tax Received in October 2025 (September 2025 processing)


County's General Sales Tax is Up 4.43% for this month compared to the same month in 2024 or Up \$70,994 in 1984 voter approved General Fund portion and Up 2.26% year-to-date compared to the same period in 2024 or Up \$250,097 (March 2025 processing through February 2026 processing).

- Two of the top fifty remitters went unprocessed for an average total of \$70,231 and one of the previous three unprocessed did not have balances close to twice their average this month for an average total of \$12,155. The top fifty remitters represent 52.80% of tax receipts.
- Current activity suggests 1984 voter approved General Fund portion of Sales Tax for 2025 will end the year at 19,469,210 which is at 95.64% of budget or \$887,040 below 2025 general revenue Fund 101 budget of \$20,356,250 and \$378,509 above 2024 actual.

#### **Trend Lines**

The 3-Month trend line increased 0.09% this month and the 12-Month trend line increased 0.09% keeping the positive gap the same at +0.07%. We continue to see sideways movement in the 3-month trend line and now the 12-month trend line has moved sideways. This type of behavior has not occurred in the past 18 years.
