Daily Briefing 08/01/17 @10:15 a.m.

Attendees: Cindy Stein, Mailyn Knight, Trysta Herzog, Tina Phillips, Bob Cirtin, Harold Bengsch and Lincoln Hough.

Bob Cirtin opens with items for consideration which is a vote for a salary adjustment for the Sheriff's office. The salary adjustment would last until December of 2018. Commissioner Cirtin asks Cindy Stein what information she has in regards to this salary adjustment. Ms. Stein explains that going through 2018 would deplete most of the reserve that had been set aside for vehicle replacement. Commissioner Lincoln Hough asks budget officer Tina Phillips for the specific cost of the salary adjustment.

Tina Phillips informs the Commission of the cost for the rest of 2017 and 2018 through December. 2017 total is \$292,300.00 this does not include the 3 people outside the current pay grade table. The 2018 total will be approximately \$500,000.00. Currently the LEST II fund has 1.2223668 million which is the Sheriffs equipment reserve fund balance.

Bob Cirtin makes a motion that the Commission approve the budget adjustment for the Sherriff's Office employees using LEST II effective thru calendar year 2018. If the November tax initiative fails the Sheriff's Office employees salary will revert back to July 2017 salary. Lincoln Hough seconds the motion. Unanimously passed. AYE: Cirtin, Bengsch, and Hough. Nay: None. Abstain: None. Absent: None

Commissioner Bob Cirtin informs the other Commissioners of the MOU-Community Foundation of Rogersville Fundraising Event. Commissioner Lincoln Hough makes a motion for approval of

the MOU. Commissioner Harold Bengsch seconds the motion. Unanimously passed. AYE: Cirtin, Bengsch, and Hough. Nay: None. Abstain: None. Absent: None

Mailyn Knight from HR passes out a proposal from OEM director Mike Dixon in regards to the Commission approving the posting of Lindsey Mericle's position and not waiting the 90 days and having Lindsey step into John Elmore's position and then having John's extra pay go for another agent. Commission will look further at the proposal but are not able to make a decision at this time. Mailyn also gives the Commission information from LeAnn Walker whom came to the Friday 07/28 D.B. to see if the Commission would waive the 90 day freeze for one of her social service deputies who are leaving Greene County. Mailyn informs the Commission of the money that the position generates. The Commission agree to allow Leann Walker to post the social service deputy immediately and forego the 90 day freeze.

Ms. Knight informs the Commission that the Sheriff's office will be adding two new transport corporal positions. Discussion of which account the salaries should be taken out of. Tina Phillips will reach out to the Sheriff to find out which account will be used for the new positions.

Cindy Stein reminds Commission that Tuesday 08/08 at 3:00 P.M. the results of the independent audit will be held in the Commission conference room.
