Pre Trial Officer Stephanie Hamilton gave an update on reporting. 260 YTD reports which is trending higher than 2018. 86 judge referrals. 56 released. Pre Trial Officer Jarod Denney gave an update on supervision. 134 currently under supervision. YTD 247 have been under supervision. 32 on GPS or SCRAM units. 93 % success rate for Pre Trial. Pre Trial Officer Ms. Yates gave an update on RANT (EX 1) Ms. Yates highlighted the report.

Director of IS Jess Kerr updated Commission that three of his staff have received a special training in cyber security and have received certificates for completion of the training, Kerr went on to thank County Clerk Shane Schoeller for providing the funds to make the training possible. Kerr thanked OEM director Larry Woods for providing the funds for a FEMA grant that allowed 3 staff members to attend a special training class and also went on to thank Cheryl Spaulding Recorder of Deeds for providing the funds to replace for the core switch replacement.

County Administrator Chris Coulter update the Commission on a project that himself and Kevin Barnes are working on.

PIO Donna Barton will be at special training next week at the PSC. Barton informed the Commission of a traveling exhibit of the capitol building that will be in archives for the next 90 days. Discussion of how to increase followers on the Facebook page were discussed. Barton also discussed a new feature on Facebook that will revolve around Code Compliance issues that are most often problems in the county.

The Commission discussed on creating a proclamation for Compositing Awareness Week.

Sheriff Deputy Randy Foster provided the Commission with the Regional Homeland Security Grant App for FY 2019. Foster explained what the grant will cover. Commissioner Harold Bengsch moved to approve the signing of the Regional Homeland Security Grant App for FY 2019 by the Presiding Commissioner. 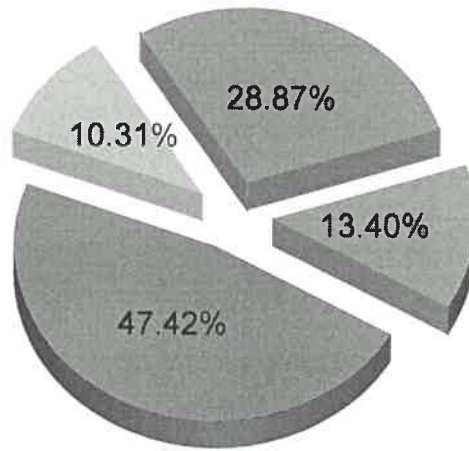
