Kendra Findley with the Health Department gave an update on the legionella cases in Greene County. Findley informed commission that there has been 2 confirmed cases. 6 cases YTD increased numbers for the year are likely because of increased testing for the bacteria.

OEM Director Larry Woods informed Commission that FEMA is coming next week to perform a public damage assessment. Assistant Director Sam Foster will be out on Military orders for 2 weeks.

E-911 Director Zim Schwartz explained that E-911 is working on accreditation which is a two year process. JR Webb gave an update on upcoming Senate Bills that could affect 911.

Executive Assistant Megan Applegate provided the Commission with orders for the Commission to sign for various board appointments. (EX1)




