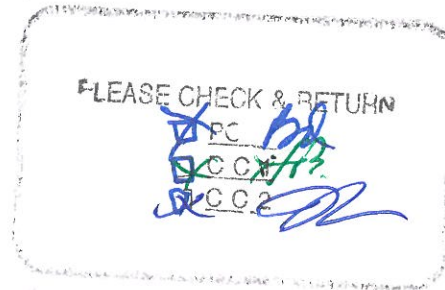

Informational Items

Health Department-Jon Mooney:

- COVID-19 update:
 - ✓ There have been zero cases in Greene County to date however the Health Department is preparing.
 - ✓ To date there have been 232 cases in the United States.

Kendra Findley:

- Tips to help stop the spread of COVID-19
 - ✓ The Health Department are asking people that have traveled from China, South Korea, Japan, Italy and Iran to monitor their temperature and keep track of any symptoms related to COVID-19.
 - ✓ The health department has met with SPS to brief on COVID-19 procedures.
 - ✓ Tips to help combat the virus.
 - ✓ Wash hands frequently and use hand sanitizer frequently.
 - ✓ Cover coughs and sneezes.
 - ✓ Avoid close contact and maintain distance, this includes handshaking.

E-911-JR Webb:

- A federal grant has been awarded to the state of Missouri.
- Greene County is currently working with Jasper County to update their 911 equipment.
- Currently 911 is answering 90% of their calls within 10 seconds it is a goal they have met in January and February.

OEM-Larry Woods:

- OEM has created a COVID-19 task force.
- OEM is working with the Health Department for united messaging about COVID-19 that will go out to the community.
- The community should plan for when COVID-19 hits and work to help stop the spread by working from home and having telephonic meetings.
