The motion to approve the aforementioned forty-one applications was seconded by Dr. Mark Maynard. The motion was unanimously approved.

Nonprofit Application Discussion

Dr. Lyle Foster discussed the following:

- A grant reporting form will be given to grant recipients to summarize their organization's projects when they are completed. Applicants will be informed of this form when they apply.
- Greene County staff members are finalizing the online and paper nonprofit application for public submissions.
- The rationale for the creation of a tiered funding system allows for organizations with different budgets to be competitive amongst peer organizations. Further, the system creates realistic funding parameters based on an organization's current operating budget. The third tier allows for the equitable consideration of organizations serving vulnerable communities disproportionately impacted by the COVID-19 pandemic.
- Organizations seeking matching funds for state or federal grants could be eligible for a grant in a tier different from what their operating budget allows.
- Expenditures incurred since March 3, 2021 can be reimbursed if they are eligible according the expenditure categories put forth by the U.S. Department of the Treasury's Final Rule.
- The Fall 2020 Nonprofit Grant Program will begin August 22, 2022. Applications will be accepted through September 12, 2022. Applications will be reviewed during and after the submission period. These dates are subject to change.

(Action 3) Dr. Mark Maynard motioned to approve a tiered system. The amount of money available in each tier will be determined by the number of applications seeking grant assistance from each tier. The motion to approve a tiered system is seconded by Bridget Dierks. The motion was unanimously approved.

The meeting was adjourned at 4:53pm.
