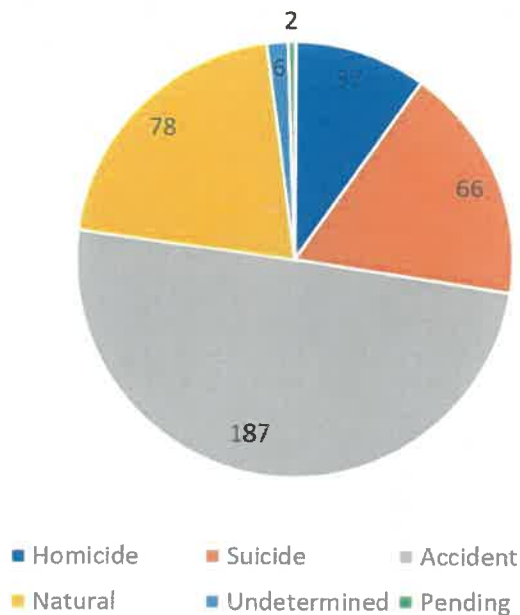

2021 Summary

- **5174 calls** reporting deaths to Medical Examiner's Office; investigators on call 24/7 to receive calls and respond to scenes
- **1149 death certificates** signed
- 65 toxicology only cases
- 376 postmortem examinations
 - 239 full autopsies
 - 119 external examinations
 - 18 partial autopsies
 - **297 autopsy equivalents** (considers 3 external examinations equivalent to the work of 1 autopsy)
- **Turnaround time** for postmortem reports
 - **66.5 days average** completion time
 - 75% of reports completed within 60 days
 - 94.7% of reports completed within 90 days

- 135 drug intoxication deaths
- 78 gunshot wound deaths
- 29 motor vehicle fatalities
- 12 deaths age 1-17
- 2 infant deaths (12 months or less)

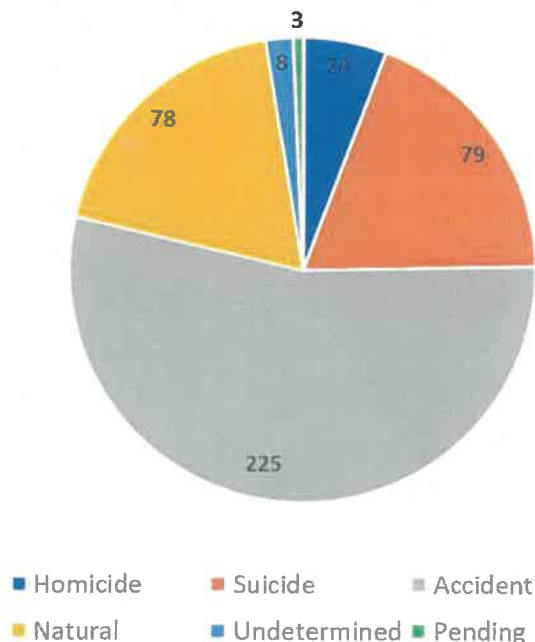

2022 Summary

- **4523 calls** reporting deaths to Medical Examiner's Office; investigators on call 24/7 to receive calls and respond to scenes
- **393 scene calls**
- **1134 death certificates** signed
- **74 toxicology only cases**
- **356 postmortem examinations**
 - 211 full autopsies
 - 114 external examinations
 - 31 partial autopsies
 - **259 autopsy equivalents** (considers 3 external examinations equivalent to the work of 1 autopsy)
- **Turnaround time** for postmortem reports
 - **58.9 days average** completion time
 - 89% of reports completed within 60 days
 - 97% of reports completed within 90 days


