SUBJECT: Reduction of Speed Limit on Farm Road 74 from 45 mph to 25 mph west of Farm Road 197.

On this 5th day of October 2023, the Greene County Commission takes up the matter of reducing the posted speed limit on Farm Road 74 west of Farm Road 197.

The Greene County Commission hereby states that appropriate notices have been given and public hearings were held on August 7, 2023, September 5, 2023, and October 2, 2023 in accordance with the Revised Statutes of the State of Missouri section 304.130.


Whereas, public comment has been offered to and received by the Greene County Commission, and after reviewing traffic study data provided by the Greene County Highway Department, the members of the Greene County Commission hereby approve the reduction of the speed limit on Farm Road 74 from 45 mph to 25 mph west of Farm Road 197.

Upon motion duly made, seconded, and unanimously carried, this Order was adopted and shall be distributed for public use, the Greene County Traffic Code shall be updated to reflect this change, and appropriate signs shall be placed.


