Commissioner MacLachlan moved to approve the Family Courts Facility Budget Adjustment and Funding for Furniture, A/V Systems, and Construction Costs including the KCI Construction Change Order. He noted this request is to be funded by the \$868,000.00 reimbursement from the 31st Circuit Court which is approved today as a budget adjustment. The remaining \$400,000.00 request today will be funded by already budgeted payments of ARPA Interest funds of \$262,216.88, at most, and already budgeted funds from the 31st Judicial Circuit Surcharge Fund of at least \$137,873.12. Amount of funds from the later source will increase to the available balance, in the fund, at the time the transfer request is made. Commissioner Russell seconded the motion and it passed.
